

## **Experts' Selection Process**

- Throughout the project, a continuous, open, and inclusive selection of experts (with focus on *SMEs*, *R&I*, and *EBSI* experts) will be implemented to support their leadership in blockchain and DLT standardisation.
- **Contributions** will be disbursed for:
  - 1. Technical reports & research studies
  - 2. New work items
  - 3. Active participation in a Technical Committee
  - 4. Other standardisation activities that meet the evaluation criteria

#### Total amount: 400.000 EUR

- ❖ Continuous selection (bi-monthly cut-offs) August 2023 – February 2025
- **❖30-40 experts** and **100** expert contributions:
  - ➤ **Short-term** contributions (3 months) one-time deliverables
  - > Long-term contributions (12 months)
    - consisting of 2 to 3 deliverables
- **❖** Maximum **3 contributions** per expert
- Maximum support of 4000Euros/deliverable

## **Evaluation Criteria - II**

#### Table 2. Selection Step 2 – Standardisation Prioritisation

Based on the achievement of the below prioritisation criteria (given between 1 and 3 points for criteria I-V and up to 5

points for criteria VI), the amount of points will be summed up with the points received in STEP 1, and the experts will be prioritised		
I. Variety of addressed priorities	Is the contribution addressing one of the priorities where a few (or none) contributions have been made so far?	
<ul><li>II. Participation in diverse SDOs</li><li>/ prioritisation of international SDOs</li></ul>	Is the contribution addressing standards / technical committees where little (or none) work has been done so far by the project experts? Is the suggested contribution linked to work being done at the international or European SDO level?	
III. Representation of the target groups	Is the applying expert helping to achieve the balance in expert representation (in terms of experts coming from SMEs / big companies / research community / European NGOs)?	
IV. Gender balance and expert diversity	Is the applying expert contributing to ensuring the gender balance of the supported experts? Is the expert representing unrepresented (or less represented) age groups?	
V. Environmental impact	Is the proposed contribution addressing environmental sustainability? What will be the impact of the proposed contribution / its outcome to the circularity and greening of the economy?	
VI. Expert leadership/ participation of new experts	Is the applying expert aiming at a leadership position? Is the applying expert a new unexperienced expert willing to get engaged into standardisation and grow towards leadership positions in the future?
