


Objective I

Experts Selection

- Continuous, open and inclusive experts' selection (bi-monthly cut-offs) August 2023 – February 2025
- First applying experts work in the following areas: eIDAS, EUDI Wallet, blockchain use cases (sustainability reporting, DPP, citizen participation in energy transition); linking blockchain to security and privacy standards; blockchain standards supporting WEB4 development.
- Next cut-off date: 15 January

Choice between short-term (3 months / 1 deliverable) or long-term (6-9 months / 2-3 deliverables) contributions


